This draft report reflects information received by October 7th.

With a 150-word limit, each candidate was asked to provide a brief biographical statement, highlighting the skills, talents, and abilities they feel would make them an asset to the deputation, as well as any prior ministry experience within congregations or the Diocese. Candidates were also asked to answer two follow-up questions pertaining to their approach as a deputy and what changes they would pursue for the wider Episcopal Church.

Committees play a crucial role in shaping legislation, making their assignments valuable. Our diocese has benefited from such roles. While deputies vote independently, caucusing and discussions – both during and before the convention – aid informed decision-making.

Alfredo Feregrino - St. Luke's / San Lucas, Vancouver

Brief Biographical Statement

The Rev. Alfredo Feregrino serves as Priest-in-Charge at St. Luke's~San Lucas Episcopal Church in Vancouver WA. He previously served for five years as Associate Rector and Director of Congregational Development and Welcome at All Saints Pasadena, the largest Episcopal church on the West Coast, where he led initiatives that strengthened connection, engagement, and growth. Ordained in 2013 as the first Latino priest in the Diocese of Olympia, Alfredo brings experience in diocesan governance, having served four years on the Standing Committee during Bishop Greg Rickel's episcopacy. He also founded Our Lady of Guadalupe Episcopal Church in Seattle, a bilingual, multicultural congregation focused on cross-cultural relationship-building. A native of Mexico City and fluent in Spanish and English, Alfredo brings gifts in leadership development, multicultural ministry, congregational growth, and collaboration across diverse communities. His ministry emphasizes unity, discernment, and mission.

What draws you to the wider Episcopal Church's work, and how would this shape your approach as a deputy?

What draws me to the wider Episcopal Church's work is the way our common life—expressed through General Convention—embodies both diversity and unity. In the midst of many voices, perspectives, and experiences, we discern together how the Spirit is calling us to witness in the world. I value the Episcopal Church's democratic and prayerful process, where bishops, clergy, and lay leaders share equal responsibility in shaping our mission. As a deputy, this would shape my approach by grounding me in both deep listening and thoughtful collaboration. While deputies vote independently, I see great wisdom in conversation, and committee work that helps us weigh complex issues with care. I would carry a spirit of openness, seeking to balance the needs of our local diocese with the vision of the wider church, always remembering that our ultimate task is to God's mission in the world.

What changes, if any, do you hope for in the wider Episcopal Church, and how would you pursue them?

I hope the wider Episcopal Church continues to grow in ways that strengthen inclusion, creativity, and collaboration. We are a church blessed with deep tradition, yet called to respond faithfully to new challenges in our time. I long to see us widen the circle of belonging across cultures and generations, encourage fresh models of ministry, and support congregations in their efforts to share the Good News in creative ways. As a deputy, I would pursue these hopes by listening carefully to diverse voices, especially those often left at the margins, and bringing their perspectives into our common discernment. I would support legislation that fosters collaboration between dioceses and congregations, believing that our vitality depends on working together rather than in isolation. Lasting change requires listening, building trust, and empowering local communities, and I am committed to helping the Episcopal Church live more fully into that vision.

Cristi Chapman - Office of the Bishop

Brief Biographical Statement

Currently, I serve as the Canon to the Ordinary for the Diocese of Olympia. In that role, I have the privilege of working closely with the bishop and key leaders throughout the diocese to discern and carry out the mission of our diocese in this new season of mutual ministry with Bishop LaBelle. I have also served as the rector of Saint David's, Friday Harbor, the Executive Director of the Mission to Seafarers, and as a canon and curate at Saint Mark's Cathedral. For three years, I also served as the convener of the Budget and Finance Committee of Diocesan Council. Before discerning a call to ordained ministry, I was a CPA and spent most of my accounting career in senior finance roles at the University of Washington.

What draws you to the wider Episcopal Church's work, and how would this shape your approach as a deputy?

Serving as a deputy will give me deeper insight into the current issues and opportunities that confront The Episcopal Church more broadly and how those impact our diocese. My hope is that this will help me be more effective and faithful in my work supporting the bishop and working with all of you in our diocese. Making connections and building deeper relationships across the church is also important. I've had the opportunity to do that with fellow Canons to the Ordinary through Province VIII and with transition ministers throughout the church. Continuing to build these relationships so that we can learn from each other, share what's good and holy about our ministries is important, and discern how we might creatively partner with each other in the future.

What changes, if any, do you hope for in the wider Episcopal Church, and how would you pursue them?

This is a unique time for The Episcopal Church with a new Presiding Bishop. PB Rowe's willingness to examine how "Church Center" supports ministry has been refreshing. It has also felt chaotic. It's important for the PB to communicate clearly (e.g., wider church and the House of Bishops) what his vision is. How the triennial budget reflects that vision and that of General Convention is critical. For instance, how does the budget support "local" ministries at the province/diocesan level? How should those be funded (e.g., TEC ask/assessment)? Discerning how other structures effectively support faithful ministry and clergy compensation and wellness (e.g., CPG) is needed. TEC also needs to find more ways to break down silos, including across diocesan and provincial lines. Some of that is happening now, but there is lots of work to be done. How clergy transitions and deployment happen is one example.

Courtney Jones - Christ Church, Anacortes

Brief Biographical Statement

I currently serve as the Interim Vicar of Christ Church in Anacortes, and have done supply in several churches in the Mount Baker Region. I live in Ferndale, and had the privilege to do a round of field education at St. Paul's Bellingham. Prior to moving to Washington, I served at a large congregation in Texas. I came to the priesthood after two decades in education, a field that requires both attention to detail and people skills. I consider myself a "church governance nerd," and have attended General Convention as both a deputy and a volunteer. As a deputy, I have previously been appointed to the Church Planting and Evangelism Committee and Liturgy Planning Committee. I have a helpful number of connections across the wider Church due to associations with the LGBTQ+ Caucus, the Association for Episcopal Deacons, and my work with Backstory Preaching.

What draws you to the wider Episcopal Church's work, and how would this shape your approach as a deputy?

Having grown up a queer Southern Baptist kid in the Texas Panhandle, the Episcopal Church was a lifeline for me. It was really the first place where I felt accepted as I was, and able to grow into who God was calling me to be. Truly, it was the first place where I felt that I could have a meaningful relationship with the living God. I want to be involved in Church Governance because I want the Church of the future to be for others what it has been for me: a place of welcome and transformation. This desire forms my approach to being a deputy, in that I'm evangelism-focused, discipleship-focused, and focused on policy that elevates the voices and leadership of young adults in the Church.

What changes, if any, do you hope for in the wider Episcopal Church, and how would you pursue them?

What I hope for in the wider Episcopal Church is that we would lean more into becoming a Church of welcome, evangelism, and reconciliation. I would love for more people who have felt rejected by the Church to find a home in the Episcopal Church. I'd love it if, as a Church, we made a compelling case for why it's great to be both "spiritual" AND "religious." As a deputy, I would pursue this by supporting initiatives that strengthen evangelism and discipleship, so that more congregations feel empowered to share their faith in authentic, inviting ways. I would also advocate for leadership opportunities that lift up diverse voices, knowing that we are strengthened by the wisdom brought to the table by historically marginalized voices. I believe this work is tied to the work of reconciliation that God is doing in the world.

Elise Johnstone - St. John the Baptist, Seattle

Brief Biographical Statement

It has been a blessing to serve as the Rector of St. John the Baptist, West Seattle since 2021. I am a graduate of the General Theological Seminary (M. Div.), and the Sewanee School of Theology (Doctor of Ministry in Liturgy). I've served in congregations (Good Shepherd, Lexington KY and Holy Trinity, Georgetown KY) as well as the Canon to the Ordinary in the Diocese of Lexington (2014-2021) prior to serving St. John's. In 20 years of ordained ministry, I strive to be grounded in our Episcopal liturgy, theology, and ethos; and work with lay leadership with energy, enthusiasm, that we, together, can see where the Holy Spirit is empowering us to follow God's call. Continual formation in congregational development (like CCD) as well as work with reckoning, truth-telling, and repair in terms of the Episcopal Church's past, present, and future has undergirded me and the context in which I serve.

What draws you to the wider Episcopal Church's work, and how would this shape your approach as a deputy?

For most of my life, I have valued the relationships and network that is the wider Episcopal Church and the Anglican Communion. I have found that we can inform one another's experience, to help us see the joys and struggles of mission and ministry in different contexts. I have served as a Deputy to General Convention (2012, 2015, 2018, serving as chair in 2015 and 2018) from the Diocese of Lexington, and I served as the 1st alternate deputy for Olympia in 2024. On the Church-wide level, since 2016, I served as a member, the Episcopal vice-chair, and the chair of the Presbyterian-Episcopal Dialogue. I am currently a member of the Standing Commission on Ecumenical and Interreligious Relations, and the Task Force on the Anglican Communion and Countering the Colonial Mindset. My experience in the parish and diocese have informed how we can, in wider connection, can work together at our best, and also deal with deep challenges.

What changes, if any, do you hope for in the wider Episcopal Church, and how would you pursue them?

It would be a privilege to represent Olympia as a Deputy to General Convention. I have experienced first-hand when the Church (at all levels) is resistant to change, and also work to build relationships, be formed by God and others to empower healthy change. I hope that the Episcopal Church can continue to adapt in order that we can continue to share the Good News of Christ and also continue to confront the issues of power, privilege, racism, oppression, colonialism, and more as we work together to live into God's call.

Eric Stelle - St. John's, Gig Harbor

Brief Biographical Statement

Raised in the evangelical church, I discovered Anglican worship while living in Northern Ireland as part of a community of reconciliation in the late 90s. I was confirmed in the Anglican Church of Canada while doing my MDiv, then - after a year's study at Sewanee - ordained in the Diocese of Alabama. I have served as rector of St. John's, Gig Harbor for 14 years. I chaired the Commission on Liturgy and Arts for several years and currently serve on Diocesan Council. I think in both theological and strategic frameworks, desiring to create structures and systems that best foster the core values of our faith that are needful for the context. This skill has been central to our parish's clarity of mission, both during COVID and in our current political situation. On council, I have a particular focus on discerning wise diocesan systems that will best serve smaller congregations. (As for being part of a convention delegation: I'm generally a nice person who'll make sure nobody gets lost!)

What draws you to the wider Episcopal Church's work, and how would this shape your approach as a deputy?

A hallmark of Anglican identity is our ability to take seriously the questions our society is asking, then looking afresh to our gospel to encounter news that is, truly, "good news" for each generation. With so many existential crises facing our nation and world, I want to be witness to, and participant in, our Episcopal Church as it interprets our gospel in lively and necessary ways, for the love of this world.

What changes, if any, do you hope for in the wider Episcopal Church, and how would you pursue them?

Whereas we Episcopalians do a very good job of translating the values of our gospel to the cultural and political context of our days, I would like to see us developing a deeper methodology and practice of spiritual discernment: seeking the living guidance of the Holy Spirit to direct us in how we are being called into mission. For we are more than a religious trumpet of progressive values, we are the mystical body of Christ. We carry a distinctive witness of redemption, hope, and unity which the world is desperately craving. But a growing edge of our discipleship is the discernment of the Spirit's specific leading in how to embody this gospel. If elected as a delegate, I would like to foster such a prayerful, discerning spirit and practice within our delegation - both in the season leading up to the convention, as well as during the convention itself.

Hillary Kimsey - St. Antony of Egypt, Silverdale

Brief Biographical Statement

I am the vicar of St. Antony's in Silverdale, where I have served since October 2023. Prior to taking this call, I worked for 7 years as a chaplain, primarily in critical care hospital settings at Harborview and Swedish in Seattle. In addition, I have served at St. Luke's in Ballard as their curate and later as assisting priest. Previously, I have served at the diocesan level as chaplain to the Bishop Search Committee that presented the slate with Bishop Phil LaBelle. I have also assisted with diocesan retreats for young adults, taught confirmation education sessions for youth, and served as part of several annual clergy conference planning teams. I believe my skill as a writer and an active listener as well as my friendly and curious personality will be assets in this role. I am also an ordained priest under 40 who deconstructed and became Episcopalian in my 20s after growing up evangelical. My experience is similar to that of so many others who call TEC their home.

There are so many people who are desperately looking for what we offer: a place for relationships and support, avenues for community service, spiritual ritual and education, and (when we are at our best) an open-minded, warm, and truly affirming place to call home. I want to help other Episcopalians talk about their faith in a helpful way. Not because we want to convert people away from their own beloved tradition or because we think we're right and others are wrong, but because we want people to know who we are and what we're about in case they are looking for us but don't realize it. I would also love for TEC to re-learn some of our history of empowering lay leaders and embracing the ministry of the baptized more fully. Finally, I hope we will continue to work for peace and justice in our local neighborhoods and across the world, especially for those who need advocates more than ever. May we focus on Jesus's call to serve the poor, welcome the stranger, set free the oppressed, release the captives, and above all, to love God and all of our neighbors as we love ourselves.

Josh Hosler - Good Shepherd, Federal Way

Brief Biographical Statement

I've been the rector of Good Shepherd, Federal Way since 2018. In that time I've seen our congregation thrive in some ways and struggle in others, through a pandemic lockdown and beyond. My first rectorship has been marked by many challenges and joys, and gosh, do I love these people.

My first call as a priest was to St. Paul's, Bellingham, and as chaplain at Western Washington University. Those times were exciting, as I especially love working with young people. What draws you to the wider Episcopal Church's work, and how would this shape your approach as a deputy?

I have not attended a General Convention since 1988 in Detroit. I was a teenager then, tagging along with my parents. My dad was one of the official photographers, and at one point he leaned over and whispered, "We just passed a boycott of South Africa because of apartheid! See that guy? He's going to a payphone to tell Bishop Tutu the news." That was a formative moment in my development as a Christian. When I was 15, I wasn't even sure that I still believed in God. But I sure saw the power of the faith of the people all around me in Cobo Hall. We weren't just a bunch of individuals who "went to church." We were BEING the church by adopting Jesus' priorities! Let's keep doing that.

What changes, if any, do you hope for in the wider Episcopal Church, and how would you pursue them?

I still see a future for our church, but it won't look like it used to. Though we can't have certainty about what it WILL look like, we can seek clarity in our priorities and decision-making. Why do we still exist as a church? What even IS Christianity in the 21st century, and what will we insist it not become?

Let's befriend people who will never adopt the Christian faith, and let's do ministry alongside them. We don't need to "water down" our faith to do this. We need to make common cause with people who don't understand why anyone would choose to be a Christian.

It's time to jettison our culture-bound expectations of the Church and set them into a post-Christendom context. We don't have to lose all our traditions to do that. We just need to learn how to express what they're FOR.

Nic Mather - St. Stephen's, Longview

Brief Biographical Statement

I am the Rector of St. Stephen's in Longview. Representing a smaller parish with an outsized impact on its surrounding community, I would bring a unique perspective to our diocesan deputation firmly rooted in knowing the Episcopal Church at its most common expression, smaller community churches existing in communities as often the only voice of an affirming Christian faith that preaches Jesus Christ while truly, radically welcoming all. What draws you to the wider Episcopal Church's work, and how would this shape your approach as a deputy?

This work has begun to be recognized as important but the intention to be innovative and creative in addressing the unique challenges of these parishes is lacking. Second is to finally put focus and energy and money into children and youth. The Lutheran Church is as strong as it is today in part because of their robust children and youth programming. And they have robust children and youth programming because as a denomination they have made it a priority through dedicated educational resources and funding for events. The Episcopal Church is currently going backwards on this issue, it must turn around immediately if it wants to survive

Tom Sramek, Jr. - St. Andrew's, Aberdeen

Brief Biographical Statement

I am the Priest-in-Charge of St. Andrew's, Aberdeen. Though new to the Diocese of Olympia, I am not new to Province VIII, General Convention, or ordained ministry. I have served as an Alternate to General Convention in 2015 (1st, El Camino Real), 2022 and 2024 (2nd, Oregon). I would pursue such changes through advocacy, legislation, and testimony at both the diocesan and General Convention levels.

Hi, I'm April Thomson, and I am a member of St. Paul's - Bellingham. My wife and I moved to WA in 2010 and have been members in parishes of varying sizes, large to very small. What draws you to the wider Episcopal Church's work, and how would this shape your approach as a deputy?

One gift from our time during the pandemic is that we have learned to use technology in ways that honor our polity while promoting greater accessibility and inclusion. It's not necessarily required to be geographically present to participate in shaping our future, or at least not for as long. We've made good progress, but we can do more. There may always be inherent barriers, but I'm interested in continuing to explore ways we can bring diverse voices to the table.

Katelyn Cowell has been a member of St. Columba's in Kent since 2013 and serves in music, liturgical, and outreach ministries. As a cradle Episcopalian and member of the Queer community who left the church for 10 years when their childhood congregation handled the 2003 schism poorly, Katelyn has long had a passion for sharing the amazing and affirming work of the Episcopal Church and the Diocese of Olympia with those who have been hurt in the name of the church. Katelyn has a passion for sharing the Gospel with people who are not necessarily looking for it and allowing space and understanding when handling difficult conversations with those who have experienced religious trauma. Having seen the Holy Spirit moving in the Seattle restaurant community and realizing that many of those living a Christ-like life do not identify as Christian, they are passionate about outreach work that is less focused on increasing congregational membership, and more about using the Gospel to heal the hurt that has been caused by modern American Christianity and drawing people to Christ through alternate ministries.

What changes, if any, do you hope for in the wider Episcopal Church, and how would you pursue them?

I believe that the Episcopal Church, and especially the Diocese of Olympia, was made for such a time as this. We are living in a world where a majority of younger, and especially Queer, people have experienced some form of hurt in the name of Christianity. When sharing my personal stories about activism within the church with those who were raised Christian but now identify as agnostic or atheist, the vast majority of them have no idea what the Episcopal Church is or what we are doing to try to heal our divided world. Coming from a restaurant background, I believe we have a branding problem. We are offering something that people are desperately seeking, but can sometimes assume that everyone knows about the Episcopal Church and will show up on a Sunday morning eventually. With the increasing reach of Christian Nationalism, I believe we need to change our strategy to focus more on activism and outreach than on Average Sunday Attendance.

What draws you to the wider Episcopal Church's work, and how would this shape your approach as a deputy?

I am drawn to be involved in the work of the wider Episcopal Church because while much of the important work of our Church happens at the congregational and diocesan level, there is work we cannot do unless we are all together as a denomination. I was inspired to see Bishop Budde of Washington speak with a prophetic voice at the National Prayer Service in January. To me, her words had even more power because she spoke not as a lone wolf but from a theology grounded in the official positions of our church—positions that were articulated and reaffirmed through the work of successive General Conventions.
