Report of the Standing Committee (2025)**

Your Standing Committee of our Diocese of Olympia is privileged to serve with you. Our primary role, when there is a Bishop Diocesan in office, is to serve as the Bishop's Council of Advice. We are also a compliment of the Bishop's authority notably in matters of diocesan and congregational real estate/encumbrance decisions as well as reviewing and certifying the canonical processes for those in the ordination process. Standing Committees also are asked to give consent regarding any Bishop elected in the Episcopal Church. When the office of Bishop Diocesan is vacant for any reason, the Standing Committee serves as the ecclesiastical authority of the diocese. The Standing Committee has been glad to be serving with The Rt. Rev. Phil LaBelle in his first full year as Bishop of Olympia, as he was ordained to the episcopate on Holy Cross Day, September 14, 2024.

Of note, some of the members of this year's Standing Committee have served now with three different bishops, as we have members who were elected in 2021, serving first with Bishop Diocesan Greg Rickel through December 2022, then Bishop Provisional Melissa Skelton through September 2024, and now with Bishop Diocesan LaBelle since September 2024.
